Aijun Liu is an associate professor in College of Economics and Management (CEM), Nanjing Agricultural University (NJAU), China. PhD of Management, Agricultural Economics and Management(AEM), NJAU, China,2007; M.Sc in Management, AEM, NJAU,China,2002;B.Sc.in Science, Agricultural Extension and Education, Lareinstein University of Professional Education, Netherlands,2002; B.Sc. in Economics, Finance, NAU,China,1996.

2010-Present Associate Professor, CEM, NAU, China (2017-2018 visiting scholar in food supply chain management, Charles H. Dyson School of Applied Economics & Management, Cornell University); 2001-2009 lecturer, Department of Management, CEM, NAU(2003-2004 project manager in Department of Agriculture of Chinese Rural Technology Development Center (2009 -2010 visiting scholar in food marketing in Curtin University, Australia);1996-2000 Assistant lecturer in student affairs office, CEM,NJAU.

His areas of expertise are agribusiness, rural development & resource management. He was in USA, Australia and Netherlands for one-year study program and also visited Finland, India and Africa countries. He is a master supervisor for Agricultural Economics & Management (AEM), Internalization Business (IB) and MBA for over 10 years and trained over 70 students(include 10 international master students in AEM). In 2014, he was nominated as Young Academic Leaders of Qinlang project for high education by Department of Education in Jiangsu Province, China. From 2016, he become Executive member of China Society of Foreign Agricultural Economy (CSFAE). He is a member of Agricultural Brands and Market Development in Department of Agriculture and Rural Development in Jiangsu, China. He published a book as first author, more than 120 papers (29 papers in English and one book chapter in English).He chaired more than 10 projects.



Dr. Arif Saleem Memon, PhD Qualified, Department of Food Science and Technology- Meat Center, (Animal Products Technology / Meat Science) from Nanjing Agricultural University of China. Life time member of PVMC Pakistan Veterinary Medical Council. Research Officer at (PRI) Poultry Research Institute Karachi, Sindh Pakistan. Currently also holding the charge of Deputy Director, LDO under the Animal Husbandry Wing of Livestock & Fisheries Department, Government of Sindh, Pakistan From January 2023. Dr. Working as focal person for LIVAQUA World Bank Mission 2023-2024 onward, GRASP (Growth for Rural Advancement & Sustainable Progress) funded by EU. Dr. Arif has worked as an Animal Quarantine Officer under Animal Quarantine Department, Ministry of National Food Security & Research Pakistan. He has also worked as an Assistant Professor from 2004- 2009 at Baqai College of Veterinary Sciences, Baqai Medical University Karachi, Pakistan.

Dr. Arif has established testing facilities during the period of 2009 to 2016 as an Officer Incharge Animal Quarantine House & DDR Laboratories National Highway Karachi adjacent (Port Qasim) Karachi and has tested more than 100000 animals during his posting period. He attended training and meeting on Food Security & Food Safety with WHO delegations, UNIDO delegation and OIE delegation on behalf of Animal Quarantine Department while working under Federal Government of Pakistan.

Dr. Arif has also established the organisation framework and policy in private sector for Livestock growth, Sustainability, breed improvement and food safety under the umbrella of Salaam Takaful Animal Insurance from 2020 to 2022. Dr. Arif is a coauthor of International research papers & National for technical articles on Poultry etc. He is a Lifetime member of Pakistan Veterinary Medical Council (PVMC), and remain involved in different federal Veterinary Projects like Upgradation & Establishment of Quarantine Stations in Pakistan, (NAPHIS) National Animal Plant Health Inspection Service.



Qisheng Chen , male, born in 1962, master of agronomy, research fellow (level 3 professional title), plant inspection and quarantine expert, vice president of Chinese Chamber of Commerce in Cambodia, industry consultant of the Agribusiness Association of Chinese Chamber of Commerce in Cambodia, and consultant of the Cambodian Banana Alliance Association. In July 1982, he graduated from South China Agricultural University with a bachelor's degree, and in November 1985, he graduated with a master's degree from South China Agricultural University. He has been engaged in entry-exit animal and plant inspection and quarantine work for 38 years since graduating from university. He successively served as the Director of the Plant Inspection and Quarantine Division of the Shantou Entry-Exit Inspection and Quarantine Bureau of China, the Director of the Technical Center of the Shantou Entry-Exit Inspection and Quarantine Bureau, and the General Manager of Cambodia Company of China Certification and Inspection Group from June 2017 to March 2023.

In the past six years, Mr. Chen Qisheng led the team to go deep into the rice producing areas and major rice processing plants in Cambodia , scientifically use chemical fertilizers and pesticides, carry out epidemic monitoring, do a good job in plant quarantine and implement quarantine and pest control, etc., to promote the export of more high-quality agricultural products from Cambodia and Laos China ,also provides pre-shipment inspection, certification and traceability services for agricultural products such as rice exported to China.

He has actively participated in the preparation and personal teaching of China-Cambodia tropical agricultural technology training courses for five consecutive years, and jointly carried out the "Lanmei Fruit Safety Tour-Cambodia Mango and Longan Standardized Orchard Construction" project and other agricultural norms or agricultural science and technology promotion projects with the Foreign Economic Cooperation Center of the Ministry of Agriculture and Rural Affairs of China. Chen Qisheng was commended by the Chinese Embassy in Cambodia in 2022, and also by the Cambodian Rice Federation, the Agribusiness Association of Chinese Chamber of Commerce in Cambodia, etc.



Shuhuan Feng, senior oversea organic product certification project manager, works in China Organic Food Certification Center(COFCC) which belongs to the Ministry of Agriculture and Rural Affairs and is dedicated in promoting the development of organic agriculture and agricultural products in China.

She is in charge of the promotion of organic agriculture, international communication and cooperation, certification both in domestic and abroad under China organic standard, also an inspector of organic products.

In international communication and cooperation, she has repeatedly conducted preliminary communication and coordination, as well as specialized research work for the visits of Ministry of Agriculture and Rural Affairs leaders to countries with relatively developed organic agriculture; Actively maintain and develop overseas cooperative institutions, strengthen technical exchanges between China and other countries in organic agriculture, assist in the development of organic agriculture in China, and promote overseas enterprises to apply for China's organic product standard certification. At present, COFCC has 10 cooperative agencies abroad, including two cooperative agencies in Italy and Latvia during the epidemic on line.

She has completed the management of over 400 times of overseas enterprises applying for China's organic standard certification projects distributed in 5 continents. As an organic standard inspector in China she has conducted on-site inspections in more than ten countries such as Denmark, Chile, and the United States. In addition, she has national and international standard trainer qualification, participated in many times of organic inspector and enterprise inner inspector training sessions.
